There are many Skype for Business Online policies and each policy can have many settings. Typically, policy settings must be managed using a PowerShell cmdlet. With the Policy Management for Skype for Business Online module, you can manage policies through an intuitive user interface. Policies can be applied in bulk to target users and groups and the module automatically detects group changes. The application of policies can be scheduled in order to maintain the correct Skype for Business Online settings across the organization.
