## About this release

QoreStor is a software-defined secondary storage platform based on Quest’s proven DR Appliance’s resilient deduplication and replication technologies. With QoreStor, you can break free of backup appliances and accelerate backup performance, reduce storage requirements and costs, and replicate safer and faster to the cloud for data archiving, disaster recovery and business continuity.

QoreStor supports all of the major backup software applications in use today and can lower your backup storage costs to as little as \$.16/GB while reducing your total cost of ownership. (For a complete list of supported backup software, see [Supported backup applications](#).) QoreStor achieves these results using patented Rapid technology as well as built-in, variable block-based deduplication and compression.

QoreStor helps you to:

- Reduce on-premises and cloud storage costs with industry-leading deduplication and compression.
- Accelerate backup completion with protocol accelerators and dedupe.
- Shrink replication time by transmitting only changed data.
- Improve data security and comply with FIPS 140-2.
- Maximize return on investment for existing data protection technologies.
- Lower total cost of ownership through all-inclusive licensing.

QoreStor 4.1.0 is the initial release of QoreStor. See [New features](#) for more information on specific features.

## New features

New features in QoreStor 4.1.0:

- **Hardware- and software-agnostic platform** — Employ any storage hardware, backup software, virtualization platform or cloud provider to reduce costs, simplify your IT environment and maximize the return on investment (ROI) for existing technologies.
- **Next-generation storage dedupe engine** — Lower your backup storage requirements by an average of 20:1, and take advantage of enterprise-class variable-block deduplication.
- **Built-in protocol accelerators** — Accelerate data ingest by up to 20 terabytes per hour to address your ever-shortening backup windows with built-in protocol accelerators that speed write operations using optimized client-side deduplication. Only unique data chunks are sent to QoreStor.
- **Remote replication for disaster recovery** — Replicate only unique data to a remote site, reduce replication windows by 10 to 15 times, reduce network bandwidth requirements by 85 percent and shorten overall replication time.
- **Back up to the cloud** — Back up directly to the cloud over your WAN but with LAN-like speeds through source-side deduplication where only the changes are transmitted. Achieve recovery point objectives (RPOs) that are typical of on-premises deployments, even over the WAN.
- **Secure connect** — Ensure complete backups, even over poor links that disconnect often. Links can disconnect many times, but backup will continue once connection is re-established. Rest assured knowing that all data sent across the WAN is encrypted.
- **Direct-to-target backup** — Bypass the media server and back up directly to the target storage device.
- **Data security** — Address your demanding security requirements with built-in encryption at rest and FIPS 140-2 compliance. Encryption at rest uses industry-standard 256-bit Advanced Encryption Standard (AES) keys, which are generated either one time or at set intervals.
- **Best-in-class data integrity** — Count on data verification and file system health checks to overcome potential storage failures and help ensure recoverability.
- **Multitenancy** — Easily create storage groups — and containers within those storage groups — to define separate storage policies and capacities within a single QoreStor system.

## Known issues

QS-437 QS-438 QS-612	When using multiple NetVault Backup Servers to access the same QoreStor Server, use storage group, container, and user names unique to each NetVault Backup server to avoid accidental deletions.
QS-1224	In rare cases, running the <b>maintenance filesystem --check</b> command, a warning is returned that states "Warning: program compiled against libxml 209 using older 207". This can be safely ignored.
QS-1420	When executing the QoreStor uninstallation script, the script will report and continue if illegal options are entered.
QS-1446	If the QoreStor partition is not set to automount, and the QoreStor server is rebooted, the system appears to be operational but shows 0 physical capacity.
QS-1456	When a user is created with the RDA role, the secure connect role is being added by default. You may remove this role through the CLI or GUI after the user is created.
QS-1480	When a storage group and container used by NetVault Backup backup jobs is deleted, the ocafsd.log file fills with the error message " ERROR: RDA SRVR RDA_GET_SGID". <b>Workaround:</b> To clear these messages, delete the QoreStor storage group from NetVault Backup.
QS-1495	The <b>maintenance --diags</b> command does not have the <b>--delete</b> option enabled. <b>Workaround:</b> Delete the diagnostic bundles from the QoreStor GUI.
QS-1537	While storage group information is loading in the QoreStor GUI, the page incorrectly displays the message "Storage groups not available". This behavior may be observed in other GUI screens if the GUI response is delayed.
QS-1571 QS-1572	The capacity figures in backup applications do not match the capacity figures in QoreStor. This is because: <ul style="list-style-type: none"> <li>• QoreStor uses GiB, while the backup application uses GB.</li> <li>• The QoreStor metadata partition is being incorrectly identified by the backup application as storage capacity. 50 GiB of the configured is reserved for application use, and as such is not reported as capacity. When displaying capacity information, the <b>Total Capacity</b> value is equal to <b>Capacity Free + Metadata Used + 50GiB</b>.</li> </ul>
QS-1588	When running Optimized Duplication jobs in Backup Exec, the container quota is not enforced as it is for backup jobs.
QS-1595	In the QoreStor GUI, the <b>Physical Capacity</b> value shown in the system information pane refers to the licensed capacity, not the true physical capacity of the QoreStor server. To view the physical capacity, use the QoreStor CLI commands.
QS-1619	When using Secure Connect to perform a backup over the WAN, the backup may fail very intermittently with "Invalid header" errors on the QoreStor server side. The errors occur when there are network issues, and Secure Connect reconnects and retransmits the packets. Please contact Tech Support if you run into this issue.

ID	Issue
QS-1657	The help output for the user command does not list the <b>secure_connect</b> role.
QS-1660	<b>stats --network</b> output is not captured
QS-1670	For Linux clients, the full version number of RDA plug-ins is not displayed.
QS-1704	When using Secure Connect with NetVault Backup, the NetVault Backup and QoreStor servers must be on the same local network, connecting with a remote Secure Connect client over a WAN link. Using Secure Connect for communication withing a local network is not supported in this release.
QS-1706	When QoreStor is in Manual Intervention mode, it is not possible to log in to the UI. Please use the QoreStor CLI when in this situation.
QS-1746	When using NetVault Backup with the Secure Connect client, authentication processes result in frequent instances of the Event message "Successfully authenticated User backup_user."
QS-1823	In some situations, the deduplication savings for a storage group shows as 100% before a backup has occurred. Once a backup has occurred, the deduplication savings will be displayed accurately.
QS-1826	With a large number of events, the Alerts and Events dialog loads very slowly on Internet Explorer and Edge.

## Product Licensing

QoreStor offers a backend capacity licensing model to allow for simple integration with other Quest Data Protection products. A single QoreStor server can have multiple license types. For example, one QoreStor server can support both NetVault Backup and standalone licenses.

- **Standalone license** - QoreStor is licensed by the amount of backend capacity required.

QoreStor licenses are additive, meaning that if you purchase a 5TB license now, and a 10TB license in the future, you will have 15TB total capacity.

**i** **NOTE:** Licenses for QoreStor are specific to the QoreStor server. When installing a license, the System ID for your QoreStor server is required. You can obtain the System ID with the command **system --show | grep "System ID"**

## Evaluating QoreStor

QoreStor offers two methods for evaluation:

- **Default installation** - If no license is installed, QoreStor defaults to a no-cost, 1TB capacity installation supported by the QoreStor Community. This option requires no license and does not expire.
  - If a license is applied to a server running in this mode, the free 1TB is **not** added to the purchased license capacity.
  - When installed in Demo mode, the capacity is limited to 100GB.

- **Full capacity trial** - available on the Quest Software Trial site, which provides a 30-day evaluation license for up to 150TB and access to Quest Support. After the evaluation period has expired, the QoreStor server will operate in Manual Intervention mode until a license is applied. To use QoreStor beyond that time frame, you will need to purchase a perpetual standalone license.
  - If installed in Demo mode, the capacity is limited to 100GB
  - If a longer trial period is required, please contact Quest Sales.

If you have purchased a perpetual license, you can install it using the **system --license** command, as described in the *QoreStor Command Line Reference Guide*.

The information must suffice to ensure that the continued functioning of the modified object code is in no case prevented or interfered with solely because modification has been made.

If you convey an object code work under this section in, or with, or specifically for use in, a User Product, and the conveying occurs as part of a transaction in which the right of possession and use of the User Product is transferred to the recipient in perpetuity or for a fixed term (regardless of how the transaction is characterized), the Corresponding Source conveyed under this section must be accompanied by the Installation Information. ## Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.

For example, if you distribute copies of the library, whether gratis or for a fee, you must give the recipients all the rights that we gave you. You must make sure that they, too, receive or can get the source code. If you link other code with the library, you must provide complete object files to the recipients, so that they can relink them with the library after making changes to the library and recompiling it. And you must show them these terms so they know their rights.

We protect your rights with a two-step method: (1) we copyright the library, and (2) we offer you this license, which gives you legal permission to copy, distribute and/or modify the library.

To protect each distributor, we want to make it very clear that there is no warranty for the free library. Also, if the library is modified by someone else and passed on, the recipients should know that what they have is not the original version, so that the original author's reputation will not be affected by problems that might be introduced by others.

Finally, software patents pose a constant threat to the existence of any free program. We wish to make sure that a company cannot effectively restrict the users of a free program by obtaining a restrictive license from a patent holder. Therefore, we insist that any patent license obtained for a version of the library must be consistent with the full freedom of use specified in this license.

Most GNU software, including some libraries, is covered by the ordinary GNU General Public License. This license, the GNU Lesser General Public License, applies to certain designated libraries, and is quite different

from the ordinary General Public License. We use this license for certain libraries in order to permit linking those libraries into non-free programs.

When a program is linked with a library, whether statically or using a shared library, the combination of the two is legally speaking a combined work, a derivative of the original library. The ordinary General Public License therefore permits such linking only if the entire combination fits its criteria of freedom. The Lesser General Public License permits more lax criteria for linking other code with the library.

We call this license the "Lesser" General Public License because it does Less to protect the user's freedom than the ordinary General Public License. It also provides other free software developers Less of an advantage over competing non-free programs. These disadvantages are the reason we use the ordinary General Public License for many libraries. However, the Lesser license provides advantages in certain special circumstances.

For example, on rare occasions, there may be a special need to encourage the widest possible use of a certain library, so that it becomes a de-facto standard. To achieve this, non-free programs must be allowed to use the library. A more frequent case is that a free library does the same job as widely used non-free libraries. In this case, there is little to gain by limiting the free library to free software only, so we use the Lesser General Public License.

In other cases, permission to use a particular library in non-free programs enables a greater number of people to use a large body of free software. For example, permission to use the GNU C Library in non-free programs enables many more people to use the whole GNU operating system, as well as its variant, the GNU/Linux operating system.

Although the Lesser General Public License is Less protective of the users' freedom, it does ensure that the user of a program that is linked with the Library has the freedom and the wherewithal to run that program using a modified version of the Library.

The precise terms and conditions for copying, distribution and modification follow. Pay close attention to the difference between a "work based on the library" and a "work that uses the library". ## TERMS AND CONDITIONS FOR COPYING, DISTRIBUTION AND MODIFICATION

0. This License Agreement applies to any software library or other program which contains a notice placed by the copyright holder or other authorized party saying it may be distributed under the terms of this Lesser General Public License (also called "this License"). Each licensee is addressed as "you".

A "library" means a collection of software functions and/or data prepared so as to be conveniently linked with application programs (which use some of those functions and data) to form executables.

The "Library", below, refers to any such software library or work which has been distributed under these terms. A "work based on the Library" means either the Library or any derivative work under copyright law: that is to say, a work containing the Library or a portion of it, either verbatim or with modifications and/or translated straightforwardly into another language. (Hereinafter, translation is included without limitation in the term "modification".)

"Source code" for a work means the preferred form of the work for making modifications to it. For a library, complete source code means all the source code for all modules it contains, plus any associated interface definition files, plus the scripts used to control compilation and installation of the library.

Activities other than copying, distribution and modification are not covered by this License; they are outside its scope. The act of running a program using the Library is not restricted, and output from such a program is covered only if its contents constitute a work based on the Library (independent of the use of the Library in a tool for writing it). Whether that is true depends on what the Library does and what the program that uses the Library does.

1. You may copy and distribute verbatim copies of the Library's complete source code as you receive it, in any medium, provided that you conspicuously and appropriately publish on each copy an appropriate copyright

notice and disclaimer of warranty; keep intact all the notices that refer to this License and to the absence of any warranty; and distribute a copy of this License along with the Library.

You may charge a fee for the physical act of transferring a copy, and you may at your option offer warranty protection in exchange for a fee.

2. You may modify your copy or copies of the Library or any portion of it, thus forming a work based on the Library, and copy and distribute such modifications or work under the terms of Section 1 above, provided that you also meet all of these conditions:

- a. The modified work must itself be a software library.
- b. You must cause the files modified to carry prominent notices stating that you changed the files and the date of any change.
- c. You must cause the whole of the work to be licensed at no charge to all third parties under the terms of this License.

However, linking a "work that uses the Library" with the Library creates an executable that is a derivative of the Library (because it contains portions of the Library), rather than a "work that uses the library". The executable is therefore covered by this License. Section 6 states terms for distribution of such executables.

When a "work that uses the Library" uses material from a header file that is part of the Library, the object code for the work may be a derivative work of the Library even though the source code is not. Whether this is true is especially significant if the work can be linked without the Library, or if the work is itself a library. The threshold for this to be true is not precisely defined by law.

If such an object file uses only numerical parameters, data structure layouts and accessors, and small macros and small inline functions (ten lines or less in length), then the use of the object file is unrestricted, regardless of whether it is legally a derivative work.
