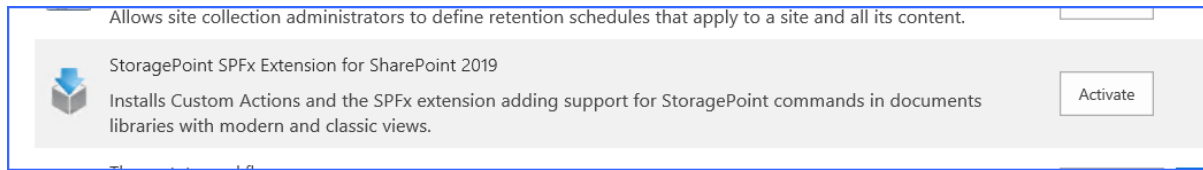

## 5.9

### Features

#### Support for SharePoint 2019

Release 5.9 will introduce support for SharePoint 2019. Large File Uploads for SharePoint 2019 will be supported in a future release. All other functionality is available. (401246)

To view StoragePoint Details in SharePoint 2019, pop up blockers should be disabled.

How to Turn Off the Pop-Up Blocker in Internet Explorer:

1. Open Internet Explorer.
2. Click or tap the Gear button or Tools menu. If you don't see either, press the "Alt" key and then click the Tools menu.
3. Select "Internet options". This will open the Internet Options window.
4. Click or tap the "Privacy" tab.
5. Uncheck the "Turn on Pop-up Blocker" box. Click or tap "Apply" to save the changes.

#### Modifications to Unused BLOB Cleanup Timer Job

Changes made to the UBC job are included with this release.

- Deleted sites that are still in recycling bins will be considered when running this timer job. If the content is part of a site that *could* be restored, users will have the option to skip these sites when running the timer job. (426011, 397809, 419779)
- The Analyze and Estimate feature of the UBC job has been modified for performance enhancements. (426394, 397721)

#### Content Database Tile in Dashboard

A new tile, Databases, has been added to the Dashboard which provides information on Content Databases associated with the SharePoint farm. A Storage Profile is not necessary to view this data on the dashboard. The panel will show information about the content database such as BLOB size, BLOB count, disk space required, Web Application, Status and Number of Sites.

### Other Changes

RestorePoint for SharePoint has been removed from the main menu and is no longer supported.

## 5.8

### Features

#### Scope Filter Added to Unused BLOB Cleanup Job

The Unused Cleanup Job now has a scope filter to help with larger farm cleanups, by limiting the amount of content to be analyzed. The filter can be applied down to the List level, within the profile scope.

#### Option to Remove Regular Files for Large File Upload Interface

The Large File Upload page now detects if there are files that are below the Web App upload threshold and prompts for their removal. Including regular files in the Large File Upload can cause the upload to process slower than just including files that are greater than the threshold.

#### Content Database Backup Improvements

The content database backup timer job can now be run hourly if necessary. There is also a new timer job for removing expired content database backups. Both of these are found on the StoragePoint Profile.

## Features

### Integration with Metalogix RestorePoint

A Primary feature with this release is the integration with the Metalogix RestorePoint product. The StoragePoint interface has included a page where users can restore items, folders or lists from SQL database backups. Two major interface changes have been made to help restore the content including:

- A new RestorePoint interface page with a link from the StoragePoint Main Menu.
- A new endpoint type - Content Database Backup Endpoint, which is configured on General Settings. This endpoint is for all profile content database backups. Backup Endpoints will still be used for backing up blobs with the regular profile backup synchronization.

### Additional Scope Filters for Unused BLOB Cleanup Timer Job

StoragePoint Unused BLOB Cleanup can add additional filters for endpoints and Large File Uploads. This can help speed up the process.

### Added Filtering for ULS logs on the Dashboard

The dashboard is a useful place to get an overview of the StoragePoint configuration and status. ULS log messages can be read directly from the dashboard, and now there are filters so that the errors and warnings can be sorted by profile ID, Profile Name, server, or severity level.

### E-Mail Notification for offline license activation

The offline license activation is always required if there is no direct internet access. When using offline activation, the license must be re-validated after 180 days to update changes from the license server. StoragePoint now supports email notification to remind customers of the required activation.
