It is a part of the Quest<sup>®</sup> On Demand cloud-based platform solution.

## General known issues

If the <b>Skip if the target file is the same version or newer</b> option is selected, files that were previously migrated and for which additional sharing permissions have been added may not appear in the <b>Shared With Me</b> panel of users who have been granted this additional sharing permission. <b>Workaround:</b> Remove and re-grant permissions directly to previously migrated files in the target. Statistics related to permissions can be incorrect in some specific cases.	ODM-872
Deletion of target object after the migration may not be reported.	ODM -855
In case the created Mailbox Switch task is edited and the mail forwarding direction is changed, all selected notification messages will be readdressed, but the wizard may not display notification settings correctly. <b>Workaround:</b> Select <b>Run later</b> and finish the task to re-open it. 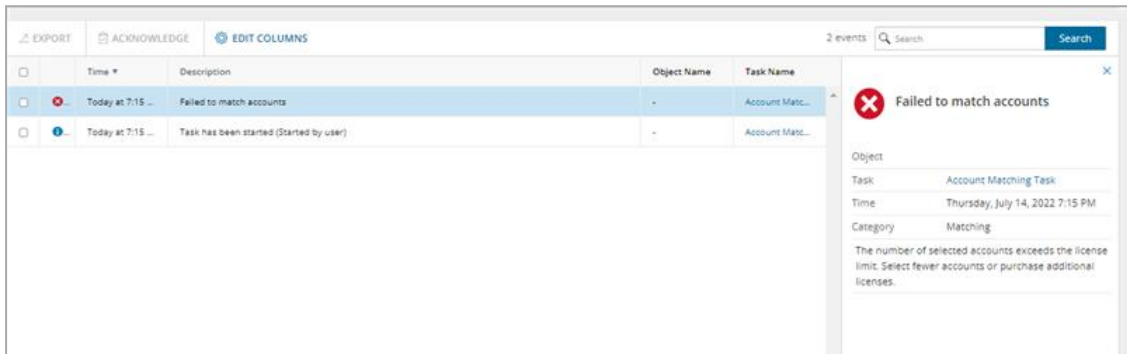
