Welcome to Foglight for SAP ASE

Foglight® for SAP ASE enables Foglight to monitor SAP ASE database systems. The cartridge monitors database resource utilization for capacity planning, problem determination, and trend analysis, in both real-time and historical time.

These Release Notes cover the resolved issues, known issues, workarounds, and other important information about the 6.1.0.10 release of Foglight for SAP ASE. Review all sections before starting the installation.

New in this release

Version 6.1.0.10 contains the following new features and updates:

- Modernize UI for Email notification management integrated with Alarm Templates introduced in version 6.0
- New role "Alarms Management Administrator" to manage "Alarm Template" and "Notifications Management"
- New REST API for export/import alarm templates and notifications
- UI usability enhancements to the navigation and search
 - Added support for managing bookmarks as part of the new left navigation panel.
 - Enhanced the left navigation to save the user preferences pinned/unpinned

- Enhanced the left navigation to be resizable
- Enhancements to the masthead area to allow setting of the management server identifier
- New Login Screen
- An Explorer option is available for users to explore data/nodes within the dashboards themselves, replacing the left navigation of the classic Foglight User Interface (UI).
- Support for GMSA
 - Added support for gMSA with Foglight SQL Server repository
 - Added support for gMSA with PI repository
- Enable PI hint added to database global view
- upgrade log4j 1.2.17 libs to 2.17.1 across all Foglight core and cartridges

Table 2. Sybase_RS Agent related known issues

Issue ID	Known issue
CR-0130361	<p>The Sybase_RS agent does not launch on AIX 5.2.</p> <p>Workaround: Since the Sybase_RS agent has the ability to perform most of its monitoring remotely, implement the following workaround:</p> <ol style="list-style-type: none">1 Choose another server which has the Sybase software (either ASE or Replication Server) installed.2 Set up the interfaces file so it has the Sybase Replication Server entry and entries for all of the other associated Sybase Servers (RSSD server, Primary Data Server, Replicate Data Server etc.) being monitored.3 Configure an instance of the Sybase_RS agent on this server (the server selected in step 1) to monitor the Replication Server running on the AIX 5.2 server. <p>NOTE: Since the Sybase_RS agent is monitoring the Sybase replication server remotely, the tables related to the replication server error log (<i>RS_ErrorlogDetail</i> and <i>RS_ErrorlogSummary</i>) do not post any data.</p>
CR-0168297	<p>Memory leak on Windows platform.</p> <p>Workaround: This is a Sybase Open Client API issue and a case is currently open with Sybase.</p>
CR-0230496	<p>The <i>RS_PartitionStatus</i> rule does not auto-clear after the partition is reset from Offline to Online.</p> <p>Workaround: This rule event must be manually cleared because we do not report partition online statuses which could possibly result in a data overload within the Foglight database.</p>
CR-0230497	<p>Latency and Synchronizing Servers. Invalid latency values reported in the <i>RS_Latency</i> table.</p> <p>Workaround: In order to report accurate latency values, all Replication Servers, Primary, and Replicate data servers within an ID server domain must be synchronized.</p>
CR-0231424	<p>The <i>RS_ConnectionStatus</i> rule does not trigger an alarm, even when the rule conditions are met.</p> <p>Workaround: There is currently no workaround for this issue. It will be fixed in a future server release.</p>
PR-063489	<p>The <i>RS_Latency_Graph</i> view has an incomplete view label.</p> <p>Workaround: There is currently no workaround for this issue. It will be fixed in a future server release.</p>
PR-063860	<p>The agent properties do not display the Agent/DCM versions after the agent starts successfully.</p> <p>Workaround: There is currently no workaround for this issue. It will be fixed in a future server release.</p>

PR-068260	<p>Unusual table names appear in the Data Browser view for the Sybase_RS agent. The RS_ThreadSummary and RS_PartitionSpaceUsedTrend table names should be listed as the table name followed by the identity columns. Only their identity columns appear in the table's hierarchy. For example, the RS_PartitionSpaceUsedTrend table should be listed as: RS_PartitionSpaceUsedTrend /apps/sybase/sybase1253/data/sq2 104 sq2 /apps/sybase/. Instead, this table is listed as:/apps/sybase/sybase1253/data/sq2 104 sq2 /apps/sybase/.</p> <p>Workaround: There is currently no workaround for this issue. It will be fixed in a future server release.</p>
PR-068923	<p>The '\n' character appears in the RS_ErrorLogMsg rule message.</p> <p>Workaround: There is currently no workaround for this issue. It will be fixed in a future server release.</p>
PR-069037	<p>Some of the graphical views display incorrect view legends.</p> <p>Workaround: There is currently no workaround for this issue. It will be fixed in a future server release.</p>
SDB-353 SDB-352	<p>On the Databases dashboard, the Up Since and Workload Info columns are not populated for Sybase_RS agent entries. That is because the Sybase_RS agent is not a database monitoring agent. This is an expected behavior.</p>

CR-0147037	<p>The <i>EngineSummary</i> Table shows intermittent negative values for <i>cpu_busy_pct</i>.</p> <p>Workaround: There is currently no workaround for this issue.</p>
CR-0203573	<p>There are an excessive number of messages in the Foglight Management Server log. If the Sybase_MDA agent attempts to collect from a database where the user does not have a login or permission to access the data, then an error message will be written to the client log file with details on how to resolve the issue. If the agent continues running without the user permission level being modified, this results in several messages being written to the client FMS log file each collection cycle.</p> <p>Workaround: There is currently no workaround for this issue. It will be fixed in a future server release.</p>
CR-0230499	<p>The <i>RS_Latency_Graph</i> view has an incomplete view label.</p> <p>Workaround: Expected Sybase behavior.</p>

CR-0230598	<p>The Sybase_MDA agent does not work on Windows. The agent has trouble automatically running the rapsinstall2*.sql scripts under Foglight 5 due to the use of a relative directory path name.</p> <p>Workaround: To work around this, manually run <i>rapsinstall2.sql</i> for any monitored ASE and then manually run <i>rapsinstall2_ase15.sql</i> for any ASE of version 15.X. CR-0230645	<p>The agent parameter Exclusion list name is not the same as in Foglight 4.</p> <p>Workaround: There is currently no workaround for this issue.</p>
CR-0230847	<p>The Agent Version and Stored Procedures Version fields are blank.</p> <p>Workaround: There is currently no workaround for this issue.</p>
CR-0230878	<p>The <i>SYBM_ASE_Availability</i> view does not show the name of the Sybase server.</p> <p>Workaround: There is currently no workaround for this issue.</p>
CR-0231131	<p>Data for <i>UsersBlocked</i> view gets displayed in <i>UsersBlocking</i> view.</p> <p>Workaround: There is currently no workaround for this issue.</p>
CR-0231189	<p><i>UsersBlocking</i> view shows incorrect data.</p> <p>Workaround: There is currently no workaround for this issue.</p>
CR-0231209	<p>Received exception: position beyond end of string from BenchMarkTimes.</p> <p>Workaround: There is currently no workaround for this issue.</p>
PR-070038	<p>The view list includes an extra database name in some of the views.</p> <p>Workaround: There is currently no workaround for this issue. It will be fixed in a future release.</p>
PR-070055	<p>The <i>Cache_Efficiency</i> Rule does not have a property named <i>dcache_name</i>.</p> <p>Workaround: There is currently no workaround for this issue. It will be fixed in a future release.</p>
PR-070213	<p>Two similar views, <i>SYBM_DbSpaceTrendBar</i> and <i>YBM_DiskSpaceTrendBar</i>, do not show data.</p> <p>Workaround: There is currently no workaround for this issue. It will be fixed in a future release.</p>
SDB-414	<p>Excluding databases can only be done by populating the Exclude DBs list manually in the Sybase_MDA agent properties.</p> <p>Workaround: There is currently no workaround for this issue.</p>

N/A	<p>Due to architectural changes in the Cartridge for SAP ASE 5.9.3.10, legacy cartridge versions cannot be upgraded to version 5.9.3.10.</p> <p>Workaround: You may install the new SAP ASE cartridge on the same FMS instance as the old cartridge. The new SAP ASE cartridge must use a different FglAM than the legacy cartridge. Both FglAMs may be installed on the same FMS.</p>

Supported platforms

Foglight for SAP ASE supports to monitor the following platforms:

- Supported SAP versions:
 - Adaptive Server Enterprise: 15.x through 16
 - Replication Server: 15.0, 15.1, 15.2, 15.7, 16.0

NOTE: Version 5.9.5.10 allows remote monitoring, hence Supported Platforms are the same as the FglAM supported platform list. Refer to the *Foglight System Requirements and Platform Support Guide* for the supported platforms.

Product licensing

Foglight includes a licensing capability that restricts access to those features that are defined in the license. Any Management Server installation requires a license that grants access to server-specific parts of the browser interface and the features associated with them. Foglight cartridges are also license-protected. While some cartridges are covered by the base Foglight license (such as Foglight Agent Manager cartridges and the Foglight for Infrastructure), others may require an additional license.

Foglight for SAP ASE is covered by the base Foglight license that allows cartridges to be installed.

To activate a trial or a purchased commercial license:

- 1 On the navigation panel, under Dashboards, click *Administration > Setup > Manage Licenses*.
- 2 Click **Install**.
- 3 In the **Install License** dialog box, click **Browse**.
- 4 In the file browser that appears, specify the location of the license file.
- 5 In the **Install License** dialog box, click **Install License**.

Getting started with Foglight for SAP ASE

Contents of the release package

The Foglight for SAP ASE 6.1.0.10 release package contains the following:

Installation instructions

Upgrade

SAP ASE cartridges former to 5.7.5.40 cannot be upgraded to the current SAP ASE cartridge version (6.1.x).

Workaround: upgrade the FMS to 6.1.x and install the latest SAP ASE cartridge

History data

To maintain cartridge history, do not remove the legacy cartridge. For the same reasons as mentioned above, the history data in the legacy cartridge is not accessible from the new cartridge. Also, as mentioned in the workaround

above, both legacy and new SAP ASE cartridges can be installed side by side. Hence legacy history will be available via the legacy cartridge.

Monitoring the SAP ASE instance

Same SAP ASE instance can be monitored by both Legacy SAP ASE agent and new SAP ASE agent (5.9.7.20), if unique FglAM and unique SAP ASE user account are used for each account.

ASP enhancements

- Changes in agent startup parameter (ASP) values no longer require the agent to be deactivated and reactivated for the change to take effect.
- Changes in agent startup parameter (ASP) values such that frequency and max rows are defined on a per-collection basis. Edit the Collection Details list to define the frequency and max rows of each collection.

Sybase open client

SAP ASE cartridge 6.1.0.10 does not require Sybase Open Client to be installed.

Installation

After installing the cartridge, update the SAP ASE account for Foglight by manually downloading and running the scripts `DB_Sybase_FirstRun_Scripts` located under *Foglight > Dashboards > Administration > Agents > Cartridges > Components for Download*.

- 1 Run script `rapsAdmin.sql` as **sa** user. This script creates only two helper stored procedures:
 - `sp_fgl_addgrant` and `sp_fgl_adduser`
 - `isql -Usa -Ppassword -SserverName -i rapsAdmin.sql -o rapsAdmin.out`
- 2 Run these scripts to complete the upgrade and to display the correct information on the new dashboards. For script execution instructions, see “*Configuring Sybase Login Privileges*” in the *Foglight for Sybase User and Reference Guide*. Failed to upgrade the user account will result in broken agent instances.
- 3 Once you have installed the cartridge, deploy the agent package. For complete information, see “*Deploying agent packages to monitored hosts*” in the *Foglight Administration and Configuration Help*. After upgrading the cartridge and starting the agent, the Agent log will display the database version, cartridge version, EBF level, and so on.
 - When you start using a new SAP ASE user or when the SAP ASE cartridge is upgraded with a new version, the stored procedures will be automatically reinstalled.
 - For RS cartridge you need to configure the path to the `sql.ini` file in the ASP with all the servers participating in the RS Agent. You can take the `sql.ini` file which exists in the Replication Server as an example.
 - When creating a new agent, it is recommended to clone all the default lists to new lists which will be used only for this agent – in the same way you did with the legacy cartridge.

Post Installation Instructions

After installing the Cartridge for SAP ASE, perform the configuration steps below:

To create a new SAP ASE user, run the following scripts as **sa** user (use your username and password).

```
exec sp_addlogin 'username' , 'password' , sybsemproc  
exec sp_fgl_adduser 'username' , 'foglightGroup'  
Grant mon_role to 'username'
```

NOTE: The new user should have only one role: mon_role.

Viewing the Cartridge for SAP ASE:

On the navigation panel, under Dashboards, click *Administration > Cartridges > Cartridge Inventory*. For details specific to the installation of the cartridge agents, see the following sections.

Sybase Adaptive Server Prerequisites: Sybase_MDA Agent

Install Sybase_MDA

The first pre-requisite is that the Sybase_MDA feature be installed on the respective ASE. This feature is not automatically installed on all versions of Sybase ASE. A check the DBA can run is the query: "select * from master..monState".

If the monitoring tables are not installed in your Adaptive Server (12.5.4 or later), have the Sybase DBA for the respective ASE follow the steps to install the tables listed in the [Addendum](#) at the end of this section.

For versions 15.x, there is no need for loopback and installmontables.

Configure Sybase_MDA

The Sybase_MDA feature has numerous parameters to both turn on and turn off specific metrics and determine the amount of memory the ASE will set aside for these metrics.

Performance monitoring how has the ability to enable the user to set the per_object_statistics flag to off.

Configure ports

Callback collections require communication between the Foglight Management Server and the Sybase server. Ensure that the port used by the Sybase host server is open between the Sybase host and the Foglight Management Server.

Sybase 'mon_role' assigned

The Sybase login defined in the Foglight agent property for the respective agent must have the "mon_role" assigned. This is also applicable to the 'sa' login.

Command to execute via ISQL or other client tool:

```
grant role mon_role to <logon_name>
```

Sybase Adaptive Server Pre-requisites: Sybase_RS Agent

The Sybase_RS agent requires separate common logins to be created for the Replication Server, the RSSD data server, the Primary data server, and the Replicate data server.

- Replication Server - Create a user with no special permission for each Replication Server being monitored.
- RSSD data server - Create a login for RSSD data server. Create a user with the same login name for the RSSD database. This user should be a member of the rs_systabgroup.
- Primary data server - Create a login with the replication_role in each Primary data server. Create a user with the same login name for the Primary database.
- Replicate data server - Create a login in each Replicate data server. Create a user with the same login name for the Replicate database. This user should have selected permission for the rs_lastcommit table.

NOTE: Refer to the Sybase_RS "*Setting Connection Details*" topic in the *Managing Sybase Database Systems online help* for more information.

Addendum

Preparation of the ASE version 12.5.4 or later for Foglight Cartridge for SAP ASE

Install MDA

If the monitoring tables are not installed in your Adaptive Server (12.5.4 or subsequent release), have the Sybase DBA for the respective ASE follow these steps to install the tables.

First, a server named "loopback" must be included in sys.servers before installing the scripts for the MDA tables. Proxy tables for the monitoring tables are not created by default when you configure Adaptive Server. The tables are created in the second step using the installmontables script that is included in the Adaptive Server install (located in the \$SYBASE/ASE-12_5/scripts directory).

- 1 Create a loopback server entry in ISQL:

Logon to Ada. and execute:

```
sp_addserver 'loopback', null, <ASE server name> go
```

- 2 Execute the installmontables script located in the \$SYBASE/ASE-12_5/scripts directory (%SYBASE%/ASE-12_5/scripts for Windows) using ISQL:

```
isql -Usa -P<sa password> -S<server name> -n -  
i%SYBASE%/SYBASE_ASE%/scripts/installmontables
```

Adaptive Server Enterprise configuration parameters

Sybase_MDA agent requires the following configuration for it to run correctly and gather the specified data for the Foglight Management Server.

The values shown for the following parameters are the minimum required values that the Foglight Cartridge for SAP ASE 5.9.3.10 needs for proper data collection and reporting. Any of these parameter values could be increased if necessary. (You can copy, paste, and execute the following script into an ISQL or other client session.)

```
sp_configure "statement cache size" <size_of_cache>

The following tables list proprietary Sybase flags and the Sybase_MDA agent tables dependent upon them. If any of the settings do not have values that fall in the recommended value range, data collection will issue complaints and fail to successfully collect; indicating that some MDA table collection was canceled as a result of the flags being set incorrectly. To prevent these alerts from occurring, use the appropriate Data Management properties to disable the collection that is failing to collect. Below is a listing of Sybase_MDA agent tables and the configuration settings they depend on:
