About Foglight for NetVault

Foglight® for NetVault®, by the means of NetVault Restful APIs, integrates Foglight for Virtualization Enterprise Edition (hereafter referred to as FVE) with the NetVault Server, and provides the following capabilities to effectively monitor large-scale NetVault deployments, including:

- Monitor NetVault infrastructure, including the NetVault Server and its affiliated clients.
- Provide and display a subset of status to FVE on demand, including Job status, Client status, Device/Storage status and statistics, and status of data being protected.
- Show NetVault reports and alarm notifications.

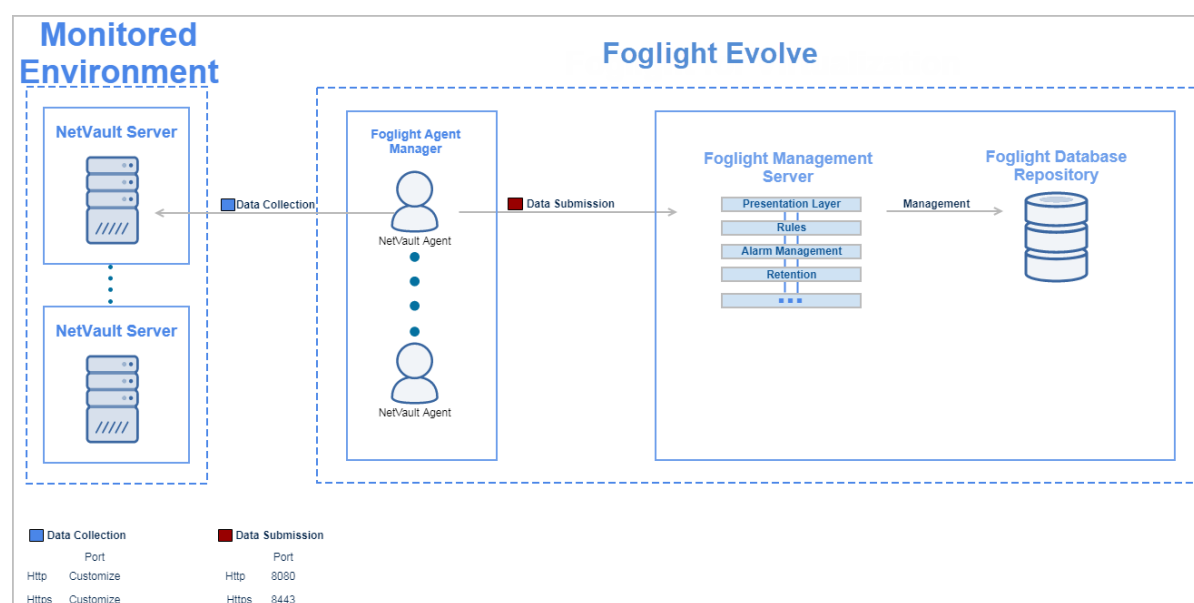
Key benefits

Foglight for NetVault offers these benefits for the customer environment:

- Better status visibility and monitoring for the complete NetVault environment.
- Single place to view the status and monitor multiple NetVault Servers and associated NetVault clients.
- Consolidated views of what is protected in a NetVault environment.
- Environment/equipment status and monitoring to help diagnose problems that can affect NetVault functionality and performance, especially where the cause of a problem is outside of NetVault control or visibility.
- Collection and display of historical status, events, performance, logs, and so on.
- More data and longer retention of data than what is stored by NetVault Servers.
- Better analysis of issues that require some history of data, for example:
 - Problems that were not noticed or reported until sometime after the occurrence.
 - Problems that are developed over time.
 - Problems that are sporadic or periodic.

Architecture

Figure 1. Components of Foglight for NetVault



Foglight for NetVault consists of three main components:

- Foglight Management Server and Foglight Database Repository — Responsible for managing, alerting, and viewing the collected data. Both components can be set to run on the same machine or reside on separate machines.
- Agent Manager — Hosts the monitoring NetVault agents.
- NetVault Backup Server — Provides the core services for protecting your data and administers backup and restore jobs for all assigned clients. Various types of physical and virtual storage devices can be locally attached to the server.

Creating a NetVault Agent

Each NetVault Agent monitors the assets inside the selected NetVault Backup environment. To enable the data collection for Foglight for NetVault, create a NetVault user with the “*Monitor Presets*” privilege, as well as grant this user with the access to the client groups and media groups that you want to monitor.

i | **NOTE:** Make sure to assign the minimum required privilege to your NetVault agent and the agent user; otherwise this agent can not start data collection.

i | **NOTE:** In FIPS-compliant mode, you need to import the CA certificate or the self-signed certificate to the KeyStore of FglIAM to use HTTPS. For more information, see [Managing certificates](#).

To create a NetVault agent:

- 1 Log in to the Foglight browser interface and make sure the left navigation panel is open.
- 2 On the navigation panel, under *Homes*, click **NetVault Environment**.
The **NetVault Environment** dashboard opens.
- 3 In the **NetVault Environment** dashboard, click **Administration**, and then click **Create Agent**.
The **NetVault Agent Wizard** dialog box opens.
- 4 **Select Agent Host:** Select the agent manager on which the new agent is to be deployed, and then click **Next**.
- 5 **NetVault Properties:** Specify the following values, and then click **Finish**.
 - **Server Address:** The IP address of the NetVault Server that hosts the agent instance.
 - **Port:** The port number used by the NetVault Server for listening to the connections from the agent instance (default: 8443).
 - **Use Https:** The option used to enable the agent connection using HTTPS (default: true).
 - **Login Username:** The name of the user that has the privileges required for connecting to the NetVault Server and retrieving information.
 - **Login Password:** The password of the user that has the privileges required for connecting to the NetVault Server and retrieving information.
 - **Error Event Keywords:** Keywords used to classify NetVault error events. Separate multiple keywords by comma.
 - **Warning Event Keywords:** Keywords used to classify NetVault warning events. Separate multiple keywords by comma.
 - **Collected Event Classes:** The option used to indicate which event classes will be collected by the agent instance. By default, all event classes available in the NetVault Server are checked.
 - **Collect Log Level:** The option used to indicate which logs will be collected by the agent instance. Warning and above is set by default.

The new NetVault Agent is created and its data will be shown on the **Monitoring** tab after a few minutes.

Managing certificates

Syntax Conventions

In order to successfully make use of the Foglight commands in your monitoring environment, review the syntax conventions before getting started. The syntax conventions are as follows:

- Generic examples follow the UNIX path structure that uses forward slashes '/' to separate directories.
- Platform-specific examples follow standard platform conventions. For example, UNIX-specific examples use forward slashes '/' as directory delimiters, while Windows examples use backslashes '\
- `<foglight_home>` is a placeholder that represents the path to the Foglight Management Server installation.
- `<foglight_agent_mgr_home>` is a placeholder that represents the path to the Foglight Agent Manager installation. This can be the location of the Foglight Agent Manager installation on a monitored host, or the home directory of the Foglight Agent Manager that comes embedded with the Foglight Management Server. For example:

Path to the Foglight Agent Manager installation on a monitored host (Windows):

`C:\Quest\Foglight_Agent_Manager`

Path to the embedded Foglight Agent Manager installation (Windows):

`C:\Quest\Foglight\fglam`

- Unless otherwise specified, Foglight commands are case-sensitive.

Managing certificates for FglAM

Foglight Evolve agents use Foglight Agent Manager (FglAM) to manage certificates for SSL encryption connection.

Prerequisite

All the certificate-related command line options require that FglAM be **up and running**.

Add a certificate

```
bin/fglam --add-certificate "user alias 1"="/path/to/certificate/file
```

- Validate the certificate and ensure the following:
 - It is not expired.
 - It is an X.509 format.
 - FglAM requires the Base64 format. To verify if the certificate file is encoded with Base64, open the certificate with a notepad and the certificate should be similar to the following example:

```
-----BEGIN CERTIFICATE-----  
XXXXXXXXXX=  
-----END CERTIFICATE-----
```

i **NOTE:** If the certificate is not Base64 format, use `openssl` command to convert the certificate file into a Base64 file. Use either of the following commands depending on the source form:

```
openssl x509 -inform DER -in xxx.cer -out xxx.crt  
or  
openssl x509 -inform PEM -in xxx.cer -out xxx.crt
```

- The `alias` is required and is used in the list and delete operations to refer to the certificate. It can be anything.

List installed certificates

```
bin/fglam --list-certificates
```

Print out a list of certificates and the aliases that refer to them.

Refer to the example output below:

```
List of installed certificates:  
  
Alias                Certificate Info  
-----  
user alias 1        XXXX
```

Delete a certificate

Remove a certificate referred to by an alias.

```
bin/fglam --delete-certificate "user alias 1"
```


A full example for managing certificate for FglAM

- Add an example certificate into FglAM certificate store

```
C:\Quest\Foglight\fglam\bin>fglam.exe --add-certificate "Evolve-test"="D:/Evolve-test.crt"
```

...

```
2020-02-27 16:31:01.000 INFO [native] Certificate added: Certificate from
D:\Evolve-test.crt added as Evolve-test
```

- List the example certificate in the FglAM certificate store

```
C:\Quest\Foglight\fglam\bin>fglam.exe --list-certificate
```

...

```
Alias                Certificate
-----
Evolve-test          Issuer:
                     CN: XXX
```

- Delete the example certificate from the FglAM certificate store

```
C:\Quest\Foglight\fglam\bin>fglam.exe --delete-certificate "Evolve-test"
```

...

```
2020-02-27 16:28:21.000 INFO [native] Certificate deleted: Certificate
Evolve-test deleted
```

Configuring data collection interval

The default data collection interval of NetVault agents is set to 10 minutes by default. Foglight for NetVault enables you to change this collection interval as needed.

i | **NOTE:** Changing the data collection interval will take effect for all NetVault agents.

To configure the data collection interval:

- 1 On the navigation panel, under **Dashboards**, select **Administration > Agents > Agent Status**.
- 2 On the *Agent Status* dashboard, select the NetVault agent that you want to monitor, and then click **Edit Properties**.
- 3 In the *Edit Properties* dashboard, click **Edit** next to the *Collector Config* field.

i | **NOTE:** Quest highly recommends setting the *Collector Config* (also known as *Collection interval*) to a value that is larger than 10 minutes and is multiples of 10 minutes; otherwise the NetVault agent might not collect metrics from the NetVault Server.

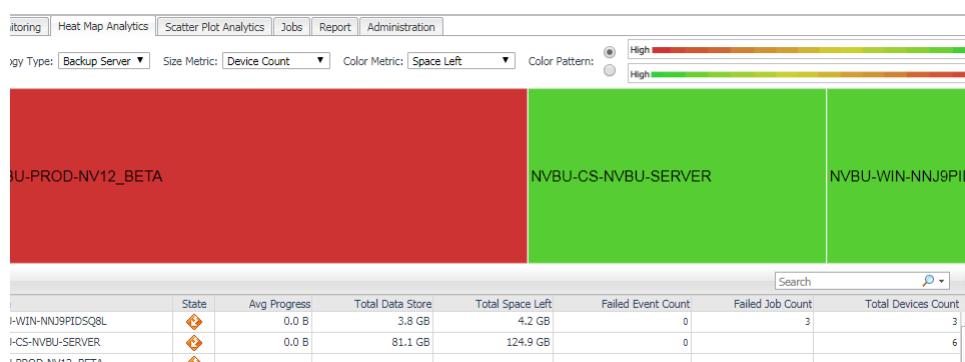
Heat Map Analytics

Heat Map is a two-dimensional representation of data in which values are represented by colors. Showing collected metrics with elaborate heat maps allows you to understand complex data sets and the monitored NetVault environment well. Heat maps will be refreshed automatically when you change either of the following fields:

- **Topology Type:** Indicates the monitored topology object, including Backup Server, Backup Client, Device Library, and Job.
- **Size Metric:** Populates a rectangle based upon the selected metrics. For example, if you select *Data Stored* from the Size Metric drop-down list, the rectangle area will be populated based on the data stored in the topology object.
- **Rendering related metrics:** For example, if you select *Space Available* and Red to Green, the rectangle of the topology object that has more available spaces will be rendered in red.
 - **Color Metric:** Renders the color of rectangle based upon the selected metrics.
 - **Color Pattern:** Offers two patterns, Red to Green (larger value shows in red) or Green to Red (larger value shows in green).

Figure 2 shows an example of heat map. This sample diagram represents the NVBU-PROD-NV12_BETA has the maximum amounts of devices and remaining spaces while NVBU-WIN-NNJ9 has the minimum amount. If you switch the Color Pattern, then NVBU-PROD-NV12_BETA will turn to green and NVBU-WIN-NNJ9 will show in red.

Figure 2. Sample Heat Map



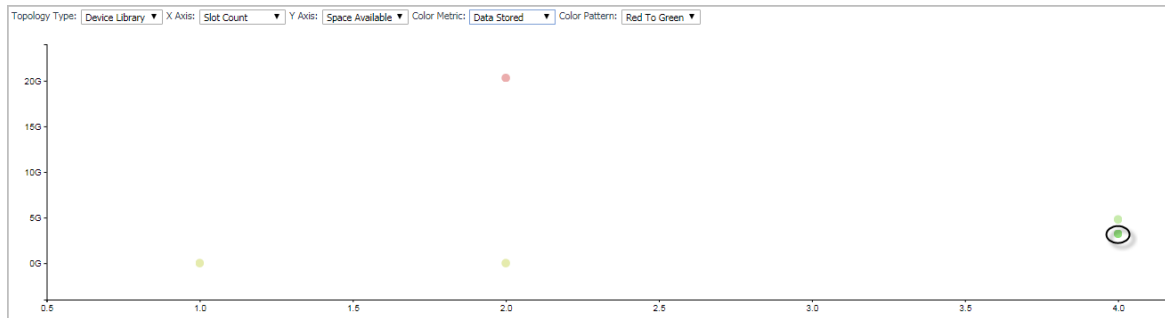
Scatter Plot Analytics

Scatter Plot is used to display values in points using two variables for a set of data. The points is color-coded also, Color Metric can be used to display one additional variable. The points on the chart will be refreshed automatically when you change either of the following fields:

- **Topology Type:** Indicates the monitored topology object, including Backup Server, Backup Client, Device Library, and Job.
- **X Axis:** Indicates which metrics will be plotted on X axis.
- **Y Axis:** Indicates which metrics will be plotted on Y axis.
- **Rendering related metrics:** For example, if you select *Space Available* and Red to Green, the rectangle of the topology object that has more available spaces will be rendered in red.
 - **Color Metric:** Renders the color of rectangle based upon the selected metrics.
 - **Color Pattern:** Offers two patterns, Red to Green (larger value shows in red) or Green to Red (larger value shows in green).

Figure 3 shows an example of Scatter Plot analytics. The green point on lower-bottom represents the following: its Slot Count is 4, its Space Available is less than 5G, and it has the minimum amount of data stored as this point shows in green.

Monitoring NetVault Backup Servers

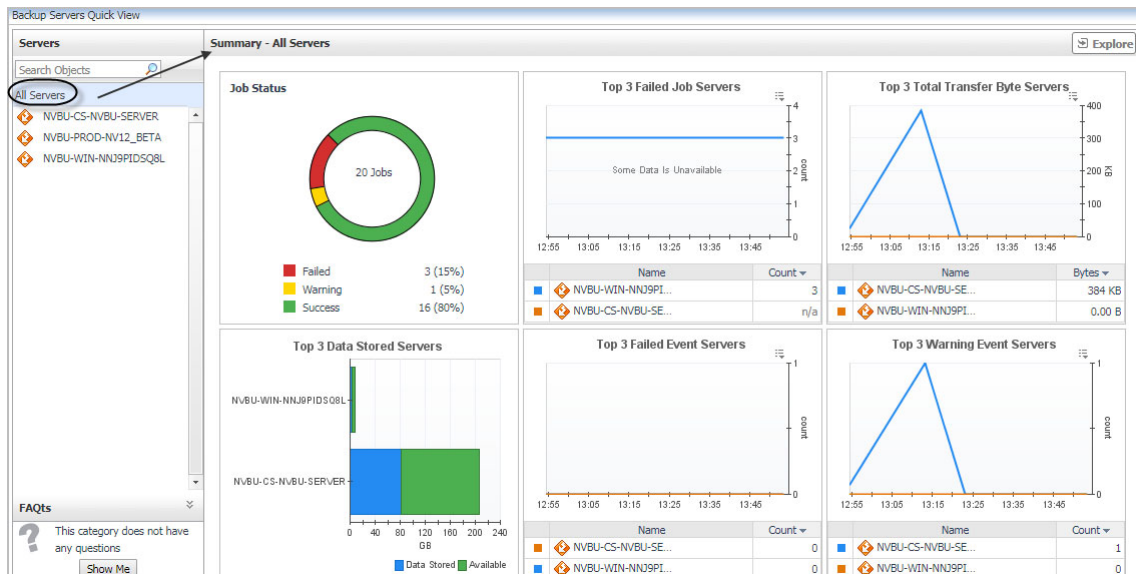
The *Backup Servers Quick View*, which appears after clicking **Monitoring > Servers**, shows the data collected about the selected NetVault environment. This view consists of the following two panes:

- The **Servers** tree view, which appears on the left of *Backup Servers Quick View*, lists the NetVault Servers existing in the monitored NetVault environment.
- The [Summary - All Servers view](#), which appears on the right after you click the **All Servers** node in the **Servers** tree view.
Or
The [Individual Server Summary view](#), which appears on the right after you select an individual server node in the **Servers** tree view.

Summary - All Servers view

The **Summary - All Servers** view appears on the right when you select **All Servers** in the **Servers** tree view.

Figure 4. Summary - All Servers view



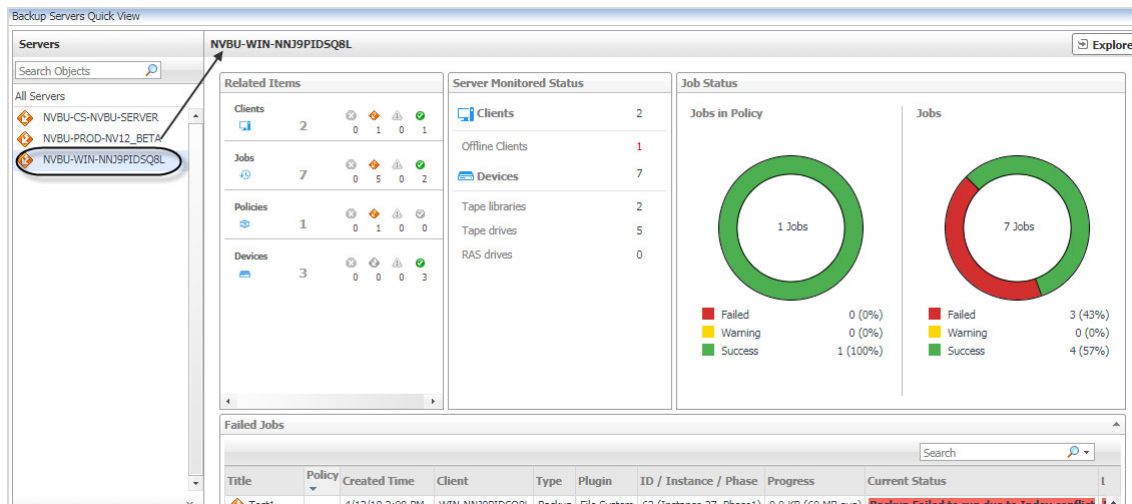
The **Summary - All Servers** view displays the following data:

- **Job Status:** Displays the number and status (Failed, Warning, or Success) of Jobs existing in all NetVault Backup Servers available in the monitored environment.
- **Top 3 Failed Job Servers:** Based upon the failed job counts, lists the NetVault Backup Servers in descending order.
- **Top 3 Total Transfer Bytes:** Based upon the value of transfer bytes, lists the top three NetVault Backup Servers.
- **Top 3 Data Stored:** Based upon the value of stored data, lists the NetVault Backup Servers in ascending order.
- **Top 3 Failed Events:** Based upon the number of failed events, lists the top three NetVault Backup Servers.
- **Top 3 Warning Events:** Based upon the number of warning events, lists the top three NetVault Backup Servers.

Individual Server Summary view

The **Individual Server Summary** view appears on the right when you select a server in the **Servers** tree view.

The **Individual Server Summary** view displays the following data:

- **Related Items:** Shows the number of Clients/Jobs/Policies/Devices that are affiliated with this NetVault Backup Server.
- **Server Monitored Status:** Shows the number of total and online Clients/Devices, and the number of Healthy/Warning/Error Jobs.
- **Job Status:**
 - **Jobs in Policy:** Displays the number and status (Failed, Warning, or Success) of Jobs existing in the policy.
 - **Jobs:** Displays the number and status (Failed, Warning, or Success) of Jobs existing in this NetVault Backup Server.
- **Failed Jobs:** Displays the detailed information about all failed jobs happened in this NetVault Backup Server.

Click **Explore** on the upper right of the **Individual Server Summary** view to open the **Server Explorer** view, which shows more detailed information about this NetVault Backup Server.

Server Explorer view

The **Server Explorer** view opens when you click **Explore** in the **Individual Server Summary** view, which includes the following tabs:

- **Server Summary tab:** This tab shows the same with **Individual Server Summary** view.
- **Server Performance tab**
- **Server Dependency tab**

Server Performance tab

The **Server Performance** tab displays the resource utilization for the selected NetVault Server over a selected period of time, which includes the following:

- **CPU:** Shows the CPU utilization summary for the selected NetVault Server based on its total capacity during a selected time period.
- **Memory:** Shows the physical memory utilization summary for the selected NetVault Server, broken into the amounts of memory that is swapped to disk, actively used, and allocated, all during a selected time period.
- **Storage:** Shows the disk utilization summary for the selected NetVault Server during a selected time period.

- **Network:** Shows the network utilization summary for the selected NetVault Server, including the average rate of network throughput, and the amounts of data sent to and received from the network.
- **Alarms:** Displays a list of alarms generated against the NetVault Server selected in the **Servers** tree view. Use this view to quickly identify any potential problems related to a specific NetVault Server.

Troubleshooting: No data displayed in the Server Performance tab

If the Host is not in the same domain with the Foglight Agent Manager on which the NetVault agent is running, there will be no data displayed in the *Server Performance* tab. In this case, do the following:

- 1 Browse to open the *hosts* file under *C:\Windows\System32\drivers\etc*.
- 2 Add the following line in the *hosts* file, then save and close.

<IP address of the host> <Machine ID of the host>

- 3 In the *Server Performance* tab, click **Add OS Monitor -> Single Host** on the top right.

The **Add Monitored Host** dialog box appears.

- 4 **Host and Agent Manager:** Specify the name or IP address of the host to be monitored, select an Agent Manager and OS type, and then click **Next**.

- 5 **Agent Properties:** Specify the following agent properties, and then click **Next**.

- **Agent Name:** Type the fully qualified host name of the machine on which the monitored the host specified in step 4.
- **Collect Top N Process Details:** Select this option if you want to collect top N server details from the monitored NetVault environment.
- **Use Ping to validate host availability:** Select this option if you want to enable the host availability validation using ping command.
- **Top CPU Processes:** Type a positive integer, for example, 5. This means the agent will collect top five NetVault Servers with the highest CPU utilization.
- **Top Memory Processes:** Type a positive integer, for example, 5. This means the agent will collect top five NetVault Servers with the highest memory utilization.
- **Top IO Processes:** Type a positive integer, for example, 5. This means the agent will collect top five NetVault Servers with the highest data transfer rates.
- **Collect Process Metrics:** Select this option if you want to collect process metrics from the monitored NetVault environment.
- **Aggregate Program Instances Data:** Select this option if you want to aggregate the data of program instances.
- **Collect Metrics:** Select *CPU, Disk, Memory, Network*, some of them, or all of them, as required.
- **Excluded Drives:** Select a list in which you want to specify the drives that you want to exclude from monitoring. You can select or clone an existing list, and edit it, as required. The default list is *defaultExcludedDrives*. Lists can be shared between multiple agent instances.

For each entry in the list, set its properties as follows:

- **Host Name Expression:** The name of one or more hosts that you want to exclude from monitoring. To specify multiple hosts, you must use regular expressions.
- **Drive Name Expression:** The name of one or more drives that you want to exclude from monitoring. To specify multiple drives, you must use regular expressions.
- **Process Availability Config:** Select a list in which you want to configure the process availability. You can select or clone an existing list, and edit it, as required. The default list is *defaultProcessAvailabilityConfig*. Lists can be shared between multiple agent instances.

For each entry in the list, set its properties as follows:

- **Process Name:** The name of process that you want to configure its availability.
- **Command Line:** The command line used to validate the process availability.

- *Expected Process Count*: The amount of expected process.
- *Include mounted remote filesystems*: Select this option if you want to include one or more mounted remote FileSystems.
- *Filesystem Type Config*: Select a list in which you want to configure the process availability. You can select or clone an existing list, and edit it, as required. The default list is *defaultProcessAvailabilityConfig*. Lists can be shared between multiple agent instances.

For each entry in the list, set its properties as follows:

- *Process Name*: The name of process that you want to configure its availability.
 - *Command Line*: The command line used to validate the process availability.
 - *Expected Process Count*: The amount of expected process.
- *Service Metrics*
 - *Collect Service Metrics*: Select either of the following: *Collect all services*, *Do not collect service*, *Collect only specified services*.
 - *Services to Monitor*: This option takes effect only when *Collect only specified services* is selected above. Select a service list that you want to collect.
- *Log Settings*
 - *Collect Log Events*: Select this option if you want to collect log events from the monitored NetVault environment.
 - *EventLog Backlog Hours*: Type a positive integer, for example, 1. This means the last one-hour log events will be saved.
 - *Event Logs To Monitor*: Select a list that includes the log classes to be collected. You can select or clone an existing list, and edit it, as required. The default list is *defaultEventLogs*. Lists can be shared between multiple agent instances.
 - *Event Log Filter*: Select a list of log filters. You can select or clone an existing list, and edit it, as required. The default list is *defaultEventFilter*. Lists can be shared between multiple agent instances.
 - *Event Log Severity*: Select a list of log severity. You can select or clone an existing list, and edit it, as required. The default list is *defaultEventSeverityMap*. Lists can be shared between multiple agent instances.
- *Collector Configuration*: This option is also known as *Data Collection Scheduler*. The default list is *defaultScheduler*.

For each entry in the list, set its properties as follows:

- *Name*: Contains the name of the default collector.
- *Interval*: Contains the length of the default collection interval.
- *Unit*: Contains the time unit for measuring the default collection interval: *milliseconds*, *seconds*, *minutes*, *hours*, or *days*.
- *Fast-Mode Interval*: Contains the length of the collection interval when the agent is running in fast mode.
- *Fast-Mode Unit*: Contains the time unit for measuring the collection interval when the agent is running in fast mode: *milliseconds*, *seconds*, *minutes*, *hours*, or *days*.
- *Fast-Mode Max Count*: Contains the maximum count of entries when the agent is running in fast mode.

6 *Credential Verification*: select one of the following options:

- *Do not configure a credential*: Select this option if you want to configure the credential for this resource at a later time.

- *Add host(s) to a new credential:* Select this option if you want to add the host to a new credential. This option is suitable if none of the existing credentials have the connection details needed to access the new host.

Then follow on-screen instructions to complete the credential verification.

- *Add host(s) to an existing credential:* Select this option if you want to add the host to an existing credential. This option is suitable if an existing credential has the security data needed to access the new host, but you need to edit its resource mappings to include this host.

Then follow on-screen instructions to complete the credential verification.

7 *Summary:* Review the information provided about the host and the monitoring agent, and click **Finish**.

Server Dependency tab

A typical NetVault environment consists of many interrelated components. Understanding the dependencies between specific components in your monitored environment and the levels of resources they consume allows you to better understand resource-related issues, potentially affecting the stability of your system. This can help you predict the impact a potential outage may have.

The *Server Dependency* tab visualizes the relationships between the objects in your environment through an interactive dependency map. The map illustrates how different components relate to each other, and the levels of the available resources available to them. The *Server Dependency* tab provides a quick and easy way to view components grouped by device.

In a large multi-component environment, dependency maps are likely complex and may not fit your screen. The **NAVIGATOR** in the bottom-right corner allows you to easily set the zoom level by dragging the slider into the appropriate position. In addition,

To find out more about an object appearing in the dependency map, click the object icon. A dwell appears, displaying more details about that object. The type and range of information appearing in the dialog box depends on the selected object's type.

Figure 7. Summary - All Clients view



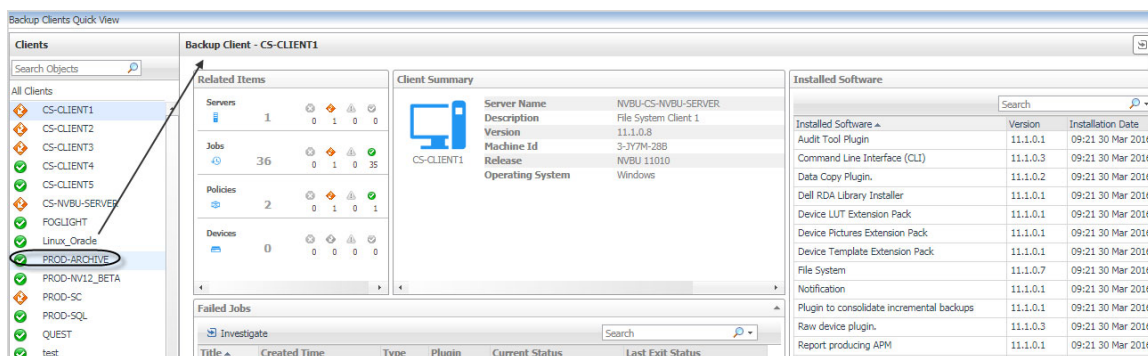

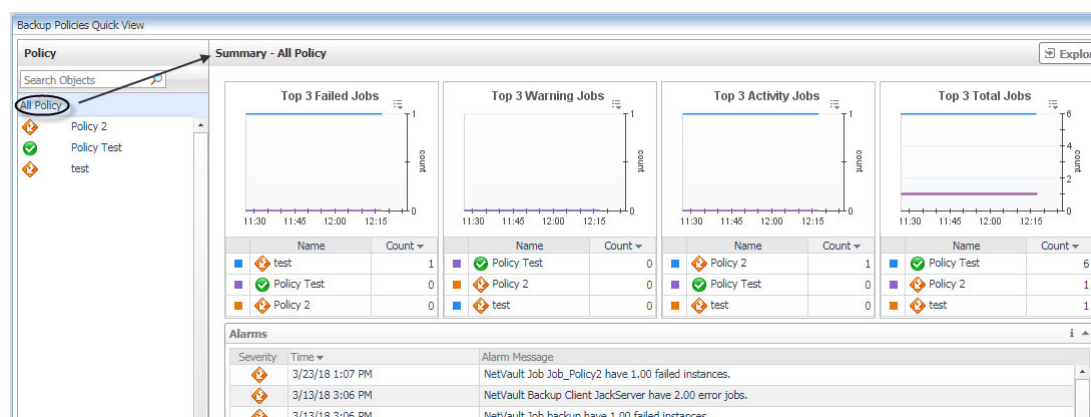

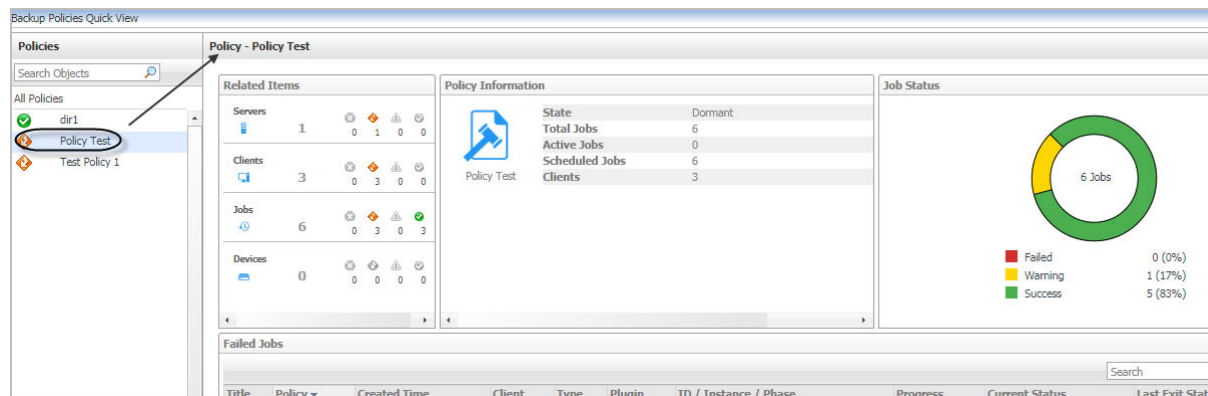

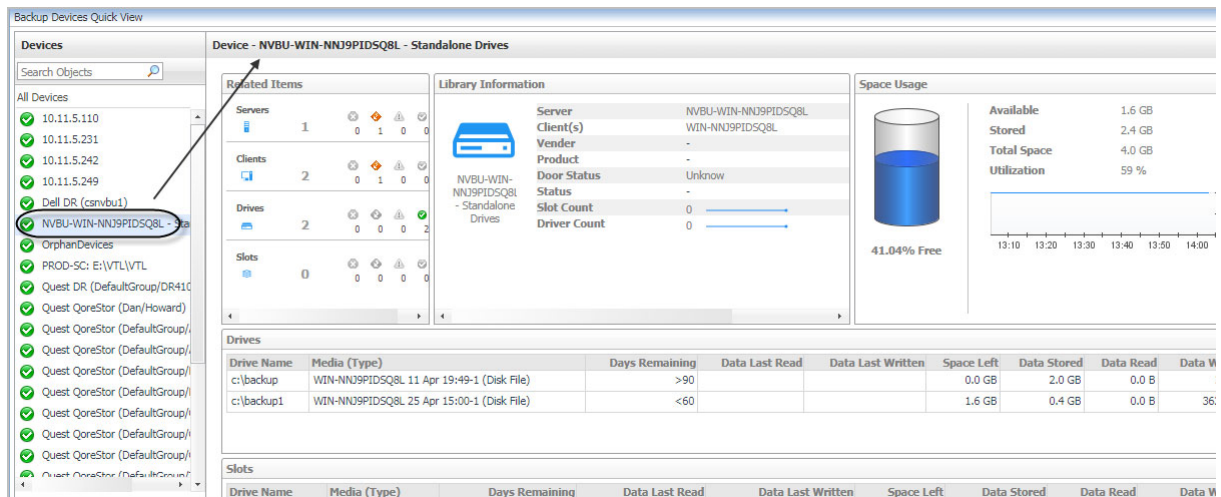
