For communication with the server:

Computers that are supposed to run InTrust Server must be configured to allow for incoming connections on the TCP port on which your InTrust Servers are configured to communicate with agents (900 by default), the TCP port used for InTrust Server management (8340 by default) and TCP port 8341.

InTrust Repository

The requirements for an InTrust repository cannot be stated definitely. This topic outlines the general considerations for choosing the right locations for your repositories.

Disk Space

Disk space requirements depend on many things, and they vary greatly from environment to environment. For some examples, see the following table:

Considerations	Comments
What kinds of events are stored?	Windows event log events are highly normalized and compress very well. In events from lesser-known logs, the field values are less predictable, and the events require more disk space.
What type of environment does the data come from?	Data from non-Windows environments, especially from Syslog, is generally the least compact.
Is the repository indexed?	An indexed repository is roughly twice the size of a non-indexed repository with the same data.

Choice of Hosting Computer

It is recommended that you host your repositories on computers that are not InTrust servers.

Repositories Not Based on Filesystems

InTrust repositories can be hosted by appliances and virtual appliances based on EMC technology. Support for these systems is provided by the use of the CAS SDK in InTrust.

The following solutions are known to be suitable for hosting InTrust repositories:

- EMC Centera
- Dell EMC Elastic Cloud Storage (ECS)

- **Deny access to this computer from network** right must be disabled.
- **Manage auditing and security log** right to gather events from the Security log; members of the local **Administrators** group have this right by default.
- Starting with Windows Server 2008, the **Network access: Remotely accessible registry paths and sub-paths** policy must be enabled, and the following registry paths must be added to it:
 - Software\Microsoft\Windows NT\CurrentVersion
 - System\CurrentControlSet\Services\EventLog
 - System\CurrentControlSet\Control\TimeZoneInformation
- Starting with Windows Server 2008, to make the Security log accessible for gathering using a specific account, this account must have the **Read** permission on the **HKLM\CurrentControlSet\Services\EventLog\Security** registry key.
- Starting with Windows Vista, if the Windows firewall is enabled, the "Remote Event Log Management" exception should be added to its configuration. Otherwise, the **Category** field is not resolved in the gathered events.

- To permit agentless gathering of logs in the **Application and Services Logs** container, enable **Remote Event Log Management** in the list of allowed programs and features in Windows Firewall configuration.

Preamble

The GNU General Public License is a free, copyleft license for software and other kinds of works.

The licenses for most software and other practical works are designed to take away your freedom to share and change the works. Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. (b) under Patent Claims infringed by the making, using, or selling of Modifications made by that Contributor either alone and/or in combination with its Contributor Version (or portions of such combination), to make, use, sell, offer for sale, have made, and/or otherwise dispose of: 1) Modifications made by that Contributor (or portions thereof); and 2) the combination of Modifications made by that Contributor with its Contributor Version (or portions of such combination).

(c) the licenses granted in Sections 2.2(a) and 2.2(b) are effective on the date Contributor first makes Commercial Use of the Covered Code.
