- Ability to select Strict Encryption for SQL Server 2022 for data sent between the client and server when using SQL as the data store.

i | **NOTE:** GPOADmin supports TLS 1.3; however, TLS 1.2 is still required to be enabled on the SQL Server due to Microsoft SQL Server 2022 requirements.

PowerShell updates

- Set-Configuration command updated for Strict Encryption for SQL Server 2022 for data sent between the client and server.
